## Instructions for Applicants

1 i) Before filling in the Application form, the applicant should carefully read the Regulations of the scheme available with the Institution concerned.

ii) The salient features of the scheme stated below.

Under the scheme maintenance allowance for the whole Course of Study at different rates will be awarded per month each for Day Scholarships and Hosteller's Boys/Girls students. Besides maintenance allowances full tuition fees and other compulsory charges will be also granted. Students are to purchase their necessary text books, stationary etc. out of the maintenance allowance sanctioned.

Students pursuing part-time Courses : Trade Courses, Correspondance Course, Short hand and Type-writing, Aircraft Maintenance Courses, P.T.T.I, Private Pilot Licence Course, Course of Training Ship Dufferin Courses of training at the Military College, Dehradun, Courses at Pre-examination Training centres will not be eligible. So long as either of the parents (or husband in the case of unemployed married girl student) are alive their income from all sources must be declared

Students pursuing studying in class XI after passing Madhyamik Examination should also apply in this form. A scholarship holder under this scheme will not hold any other scholarship/stipend.

Candidates who after having completed their educational careers in one professional studies in a different line will be eligible. But for the study in general academic line after completion of a professional course by the student will not be eligible.

Students after passing one stage of education are studying in the same stage of education in a different subject i.e., B. Com. after B. A. M. A. in one subject after M. A. in other subjects will not be eligible.

The Scholarships granted under the scheme are meant for recognised full time course of study after the Secondary/Matriculation/Higher Secondary or equivalent examination in recognised Institutions only.

2. i) This form is intended for **NEWLY ADMITTED STUDENTS ONLY** and those who have not received this scholarship in the previous year, due to break in education, for failure or other reasons.

ii) Candidates who were in receipt of scholarships previously, but have joined a higher course of study after completing a stage of education e.g. those who have joined Class XI/B.A./B.Sc./M.B.B.S./M.A./M.Sc. etc. after passing Madhyamic/H-S/Pre-University/B.A/B.Sc. etc. should apply in Fresh Forms.

- iii) NOBODY IS ENTITLED TO APPLY FOR SCHOLARSHIP (a) For two courses of study simultaneously, M A./M Sc./M.Com. students may however apply for L.L.B/B.T. Course also and vice. versa.
- b) Students in full-time employment and whose income combined with the income of their parents/guardians do not exceed Rs 100,000/- per year will be eligible confined to reimment of all compulsory non-refundable fees.
3. Schedule Caste, Sch. Tribes candidates belonging to/permanently settled in West Bengal and reading in colleges situated within the Calcutta Corporation and those reading in the colleges situated outside West Bengal have to apply to their respective State Govt through the heads of the respective Institution.
4. Scheduled Castes, Sch. Tribes candidates belonging to permanently settled in West Bengal and reading in the colleges situated in the district of Bardhaman will have to reply to P.O cum DWO. B.C.W/Burdwan through the head of the Institutions and to submit the application to this office directly by the applicant as soon as it is filled in only to receive the Entitlement Card, in case of Durgapur/Asansol/Kalna & Katwa should have to apply in the respective Sub-divisions B. C. W. Officers/S.D.O's Office.
- 5 a) The application should invariable be accompanied with the following document otherwise the application is liable to be rejected.
- i) Xerox copy of admit, Marksheet of the last Examination passed, duly attested.
  - ii) Admission Fee Receipt (Attested)
  - iii) Caste certificate from the Authorised, officer.
  - iv) Pay slip, Income certificate from M.L.A./M.P /Municipal Commissioner/Member of Zilla Parishad/in case of service holders he should submit Income certificate from his officer.
  - v) Declaration of income in the annexed form 'A' (where parents are alive their income must be (declared). Income means gross income including allowances other than house rent allowance if is not assessable to income tax rental value of the house if exempted for purpose of Income tax should not be taken into account for the purpose of calculating income of the parents in case of candidates whose parents own a house and have not let out any portion thereof as rent. Service-holders should furnish certificates from the employers showing gross monthly emoluments in other cases full details of business extent of land hold should be furnished.
  - vi) Three copies of passport size photo (To be attested by the Head of the Instt./College/ Head of the Deptt.)
  - vii) Hostel certificate form hostel Supdtt. ( In case of hostel student) with admission date of Hostel duly counter signed by the head of the Institution.
  - viii) Previous E/card for B.A., B.Sc./B Com, and other on words accademi qualified applicant.
  - ix) Xerox copy of Enrolment Card for M.A./M.Com. course to be obtained them the University.
6. The last date for the receipt of the applications from the candidates newly admitted into the Institutions is 30 days from the date of admission to the class or joining to the class whichever is earlier.
7. Incomplete Applications and Applications not received within the prescribed date are liable to be rejected.
8. A Scholarship may be cancelled if the Scholar changes the course of study or the Institution without the prior approval of the authority sanctioning the scholarship.
9. All future communications in respect of an application should be made with the P.O. cum D.W O. BCW/Burdwan concerned through the Head of the Institution.
10. All changes in address should be forthwith intimated  
Candidates admitted in a recognised hostel after submission of the applications will have to submit application for hostel grant within two weeks from the date of admission to the hostel through the Head of the Institution otherwise no case is to be considered.
