The draft publication of permits under Stage Carriage category issued by Regional Transport Authority, Burdwan is hereby published for wide circulation among the bonafide operators of permit, interested parties and members of the public, on and **from 12/09/2011 to 12/10/2011** for inviting claims / objections and views, if any, with respect to the draft published list. It may be noted that the draft of Stage Carriage Permits have been prepared purely from office records and there is scope of correction / rectification against the publication.

All application in this regard should be addressed to the Secretary, Regional Transport Authority, Burdwan in a closed envelope with the heading- "Response to Draft Publication of Permit by RTA, Burdwan" along with complete details of name, address, permit number, operating vehicle number, detailed route with via points and contact telephone number / mobile number, specific comment regarding his / her claim / objection / view etc. and submitted to the office receiving counter within the office working hours in the period mentioned above. A draft model specimen of application for this purpose is also annexed with this notice.

No application in this regard will be entertained after the closing of deadline fixed for the purpose on 12/10/2011.
