ORDER

In pursuance of provisional sanction order and other available record a sum of Rs. 10.50 lakhs (Rupees Ten lakh fifty thousand) only, out of fund under MPLADS of Shri Ram Chandra Singh, Hon'ble MP, Rajya Sabha is hereby released in favour of the Executive Agency against scheme for immediate implementation and submission of utilisation of fund as detailed below for the year 2010-11.

The responsibility of repair and maintenance of the durable assets so created with the above MPLADS fund will be on the organization availing the benefit. Further the executing agency is liable to maintain an Asset Register for the assets so created out of above MPLADS fund.

The utilization of fund under this sanction should be made as per guideline framed in this behalf by the GOI and the utilization certificate in specified format (SR 330A) alongwith photograph of the executed scheme and work completion report be submitted to the District Planning Officer, Burdwan.

Plaque (stone/metal) carrying inscriptions "MPLADS works with the name of MP" indicating the cost involved, the commencement, completion and inauguration date may be permanently and prominently erected at the site of works for the awareness of the local people.

Monthly progress report in respect of physical and financial performance of the schemes may also be submitted regularly to this office.

Executing Agency is requested to collect the cheque / draft from the Office of the District Planning Officer, Development and Planning Section Unnayan Bhawan, Burdwan immediately after the receipt of this order.
